Background on LA Cannabis Policy and the Role of DCR and CRC



History on Cannabis Policy in LA



In March 2017, Measure M, passed in the City of Los Angeles by more than 80% of voters, giving the City Council the full authority to regulate cannabis-related activity within the City of Los Angeles. With that authority, the Department of Cannabis Regulation was established by ordinance on July 30, 2017.

Since then a lot has happened.

On July 1, 2020, the Los Angeles City Council approved an <u>ordinance</u> which comprehensively amends, clarifies and re-organizes portions of Article 4, Chapter X of the Los Angeles Municipal Code. The ordinance became effective upon publication.





Department of Cannabis Regulation (DCR)



The Department of Cannabis Regulation (DCR) is responsible for administering the commercial cannabis licensing and regulatory program established by the Los Angeles City Council. Specifically, DCR processes all applications for commercial cannabis licenses in the City of Los Angeles, makes licensing decisions or licensing recommendations to the Cannabis Regulation Commission, and regulates the operations of licensed commercial cannabis businesses in the City.





Cannabis Regulation Commission (CRC)



The Cannabis Regulation Commission was established by <u>ordinance</u> on July 30, 2017 and holds a number of important roles in cannabis licensing in the social equity program in Los Angeles.

Licensing Program



Licensing Program



In order to participate in Commercial Cannabis Activity within the City of Los Angeles, both a state license and a local license are required.

<u>The Cannabis Procedures</u> establish the manner in which the Department and Commission are required to process commercial cannabis license applications and further establish requirements of commercial cannabis applicants and licensees.

The Cannabis Procedures authorize the Department and Commission to issue licenses for the following commercial cannabis activity types: cultivation, manufacturing, distribution, testing, retail and delivery.

The City of Los Angeles also established a Licensing and Social Equity Program that enumerates various restrictions related to licensing and application processing.

Before making license applications available to other applicants, local law required DCR to administer application processing for certain existing operators pursuant to LAMC <u>104.07</u> and <u>104.08</u>. Applicants pursuant to these sections are often referred to Phase 1 and Phase 2 Applicants, respectively. The application process for both of these application types has CLOSED.



Licensing Program: Location Requirements and Sensitive Use Restrictions



The City of Los Angeles restricts where Commercial Cannabis Activity may lawfully occur. The City restricts Commercial Cannabis Activities to specific zones.

Sensitive use restrictions include but may not be limited to following:

- A licensed retail storefront must be outside of a 700-foot radius of a School, Public Park, Public Library, Alcoholism or Drug Abuse Recovery or Treatment Facility, Day Care Center, Permanent Supportive Housing, and any other licensed storefront retailer.
- A licensed non-storefront retailer (delivery), distributor, cultivator, non-volatile manufacturer or testing lab must be outside of a 600-foot radius of any School.
- A volatile manufacturer must be outside of a 600-foot radius of any School and a 200-foot radius of any Residentially Zoned Property.





Licensing Program



Commercial cannabis licensing is categorized three (3) distinct phases in the City:

- Phase 1
 - Existing Medical Marijuana Dispensaries (EMMDs)
 - Began in January 2018
- Phase 2
 - EMMD supply chain
 - Began in August 2018
- Phase 3
 - New Businesses Social Equity Applicants & General Applicants
 - Began in September 2019

455 Commercial Cannabis Businesses have Temporary Approval to operate in the City of Los Angeles. A breakdown of the licensed activities is provided in the table below:








Purpose of SPARK






SPARK Surveys

SPARK SURVEYS will be available through June 30, 2021.






SPARK Comment Box
