Instructions: This form is required as part of the licensing process for a commercial cannabis business to obtain a license in the City of Los Angeles. This form requires that the property owner or their agent: (1) acknowledge that the Applicant has the right to occupy the Business Premises identified on the Applicant's license application for the purpose of conducting commercial cannabis activity; and (2) attest that the Business Premises location is not ineligible for licensure for certain reasons specified below. This form must be signed by the property owner, an agent of the property owner, or if an entity owns the property, an officer of that entity. If signed by an agent or officer, a document or disclosure identifying the agent or officer must also be submitted.

A Business Premises location is ineligible for licensure for the following reasons:

- The Business Premises is owned or managed by a Person who holds office in any agency of the State of California and any of its political subdivisions, including the City and any of its agencies, departments, commissions or boards of the State of California or its political subdivisions when the individual's duties include the enforcement or regulation of Commercial Cannabis Activity or any other penal provisions of law of the State of California prohibiting or regulating Commercial Cannabis Activity.
- The Business Premises was the site of illegal volatile Cannabis manufacturing under Health and Safety Code Section 11379.6 as evidenced by a conviction, for a period of five years from the date of conviction.
- The Business Premises was the site of distribution of Cannabis to minors as evidenced by a conviction, for a period of five years from the date of conviction.
- The Business Premises was the site of any illegal Commercial Cannabis Activity after April 1, 2018, as evidenced by a conviction, for a period of five years from the date of conviction.
- The Business Premises was the site of unlicensed Commercial Cannabis Activity, in violation of LAMC Section 104.15, on or after January 1, 2018, for a period of five years from the date of the unlicensed Commercial Cannabis Activity ceased.
- The Business Premises is located on any portion of any parcel of land used as an Unlawful Establishment, in violation of LAMC Section 104.15, on or after January 1, 2018, for a period of five years from the date the Unlawful Establishment ceased operations.
- The Business Premises was the site of a disconnection of utilities under LAMC Section 104.15(e) for a period of five years from the date of the disconnection.
- The Business Premises was the site of padlocking under LAMC Section 104.15.1 for a period of five years from the date of the padlocking.

As a covered entity under Title II of the Americans with Disabilities Act, the City of Los Angeles does not discriminate on the basis of disability, and upon request, will provide reasonable accommodation to ensure equal access to its programs, services and activities
